# International Association of Forensic Nurses Conference

On Monday, August 26th, representatives from the SARTAC team (Sexual Assault Response Team of Allegheny County) presented at the 2024 International Association of Forensic Nurses Conference in Denver, Colorado.

The team was asked to perform a panel discussion on the experience they gained after building SARTAC from the ground up in the early 2000's. This group was initially organized by SANE (Sexual Assault Nurse Examiner) nurses in Allegheny County to provide SANE response to all the hospitals regardless of if they had a specialized team on hand or not. This also ensured proper Law Enforcement and Victim Service response that led to better prosecution and trauma services being rendered in a timely manner.

Deb Shane (Retired UPMC SANE) was unable to attend the conference, but also made significant contributions in pioneering this multidisciplinary team.

Topics discussed during the panel included the building of a response team, multidisciplinary approaches, pros and cons of the team model, and how other states may begin to construct their own response teams, even if they do not have the same capabilities we do. As a team this panel was an excellent demonstration of the cooperation between agencies and how we work together to investigate cases and support survivors.

# **Forensic Interview Preceptorship**

ACP Forensic Interviewer, Haley, has taken on a preceptorship with Margaret, a recent Forensic Interviewer at Kay's Cottage, the Child Advocacy Center in Armstrong County, as her preceptee. The overall goal of the program is to connect a newer forensic interviewer with an experienced forensic interviewer to strengthen their interviewing skills, as well as to enhance their confidence in collaborating with multidisciplinary team (MDT) members.

Maggie has been interviewing since February of this year, and has been with Kay's Cottage for just under a year. Throughout the Forensic Interview Preceptorship (FIP), Haley will be providing her with feedback on interviewing in addition to sharing training materials such as research articles and webinars that may be helpful to her journey as a new forensic interviewer. Maggie has already traveled to Mercy Health Center to observe a few of Haley's interviews, and will return in the coming weeks to observe more. Haley will be traveling to Kay's Cottage to observe some of her interviews as well.

## **Healthy Parenting Impact Story**

### My name is Vincent S. Scott.

I am the father of four wonderful children, Alia Tenaye 35, Jay Lyn 26, Vincent Elijah 23, and Zipporah Faith 8. I was referred to ACP (A Child's Place PA) during a tumultuous time in my life, dealing with an addiction and life on terms with being a father. Children Youth Services had involved themselves and taken custody of my youngest daughter, Zipporah.



Dr. Deonna Dykes was assigned as my parent advocate, and immediately she began dissecting issues and problems she heard me share with her about my situation. I was given a few workbooks in which to reference and work out of. Unfortunately, I was incarcerated, and the work we were doing halted. However as soon as I was released, I notified Dr. Dykes and asked if she could continue to help me. She accepted, and for many years now she has impacted my life in terms of making me a better father not just to my youngest, but to all my children.



We have all benefited from work I've done with Dr. Dykes. When we started the work I had supervised visits with Zipporah once a week for 2 hours, and today I get unsupervised weekends and holidays. I was the best man at my son's wedding this past year. My oldest daughter includes me in her and my granddaughter's life. My estranged daughter has reached out to me and asked me to come meet my three grandchildren. All these things I have mentioned would not have happened had not been for the suggestions, directions, and guidance from Dr. Dykes. I credit her for helping me build a positive relationship with my children.

## **Upcoming Trainings**

The Law Enforcement Liaison Team is developing their fourth educational topic for Law Enforcement Workshops. Previous workshops were designed to be presented to Children, Youth, and Family Services (CYF) and the District Attorney's office; however, this round of workshops will be geared directly toward Law Enforcement. In collaboration with the District Attorney's office, the upcoming topic is titled, "How to Build a Case-Guide for Investigators." Two sessions will first be offered in Allegheny County on October 4th and October 25th.

#### Outreach

Law Enforcement Liaison, Ann, and Parent Educator, Megan, presented at a department wide training at West Homestead Police Department on August 2nd. Ann spoke about the services A Child's Place, PA offers, including Forensic Interviews, Medical Exams, Victim Advocacy, and more. Megan presented information about the Healthy Parenting Program at ACP and how police officers can use it as a resource to offer families. Approximately fifteen officers participated in the training.
