

## **Healthy Parenting Impact Story**

Healthy Parenting Program client Dr. Patricia Sullivan began with the Standard Triple P program and transitioned to Stepping Stones for her 1-year-old son, Baysin. He experienced a condition at birth characterized by excess fluid build-up in the brain, called hydrocephalus, due to a brain bleed. Baysin required a fourmonth stay in the NICU and the installation of a shunt in his head to drain the excess fluid.

Initially, doctors were uncertain if he would have difficulty feeding himself, crawling, walking, or speaking. However, thanks to his mother's strength and determination, the



support of his occupational and physical therapists, and the services provided by A Child's Place PA, little Baysin has made remarkable progress. Not only can he now feed himself, but he also played independently for an hour last week. He started crawling efficiently a month ago and, this past weekend, learned to crawl up the stairs. Dr. Sullivan is very grateful for our work and dedication to the growth and development of both of her children, especially Baysin, who required the most care.

## Law Enforcement Liaison Team

#### Training

The Law Enforcement Liaison Team continues to work together offering trainings to police, the Office of Children, Youth and Families (CYF), Children and Youth Services (CYS), and other community agencies across multiple counties. On July 31st, they completed a third combined Law Enforcement and CYS Workshop in Westmoreland Co. at the Monessen High School. There were over 20 participants in attendance between both police and CYS workers, a great turnout for a third workshop. Throughout the session, there was engaging conversation and collaboration amongst the group!

The three workshops offered in Westmoreland Co, and the previous two workshops in Fayette County were structured as a full day of training including Workshop #1 (Basic Child Abuse Overview) and Workshop #2 (Minimal Facts and Forensic Interviews), that originated as a pilot program in Allegheny County. Both the District Attorney's offices and Children's Services offices of each county have also presented at these workshops. Tiffani M., Forensic Interviewer, has been working with the Liaisons Team in these trainings and has done a great job presenting the minimal facts and forensic interview portions of the trainings. Megan S., Parent Educator, has also collaborated with these trainings to present about the Healthy Parenting Program. The team is eagerly working on scheduling Workshop #4 in Allegheny County for Fall of 2024, and is hopeful to schedule an additional workshop in Beaver County soon.

#### Outreach

Law Enforcement Liaison, Ann, and Parent Educator, Megan S., have continued their outreach efforts in Allegheny County, speaking with police departments in White Oak, Duquesne, McKeesport, West Mifflin, Munhall, and West Homestead. These visits share information with law enforcement about the services we offer. Their work has been very successful, leading to an invite to speak at a department wide training for West Homestead on August 2nd. They have also been requested to speak at an upcoming multiple-department training in Brentwood during off hour role call sessions.

## **Healthy Parenting Spotlight**

#### **Allegheny County**

— The Healthy Parenting Team in Allegheny County has had a successful round of Triple P Groups at Auberle House of Healing, Passages, and Allegheny County Jail Collaborative! They also continued Parent Chats at Hearth, Women's Behavioral Health IOP, Auberle, and Hilltop Family Center.

— Megan S. attended an outreach event hosted by Judge Dan Konieczka, the magistrate of Shaler, to assist parents and their kids who had been charged with vaping. The session featured several professional speakers who spoke to the group about the hazards of vaping and resources to quit. The parents then met with Megan S. privately to learn about our Healthy Parenting Program, strategies to build a positive relationship with your teen, and how our program can support them as parents. The event was complete with donuts and juice, and all in attendance were dropped of their charges.

— On July 26th, Parent Educators Deonna and Lloyd attended the Jerebear Fair held by Jeremiahs Place, Pittsburgh's only crisis nursery, at the Kingsley Association. The fair featured carnival themed food, fun games and activities, music, raffles, and resources from partner community agencies. This event was well attended with the PEs speaking with a total of 44 families. One of the families were already enrolled with us!



#### **Fayette County**

— The PAT team attended a Beverly's Birthdays event in Uniontown to outreach for Parents as Teachers. Beverly's Birthdays is a nonprofit organization that provides birthday parties to children experiencing homelessness, and families otherwise in-need.


— Parent Educators Tristan & Kate have continued to deliver the Positive Parenting Program to the Men's & Women's groups at the Fayette County Jail.

## **Tech Tip: Scheduling Assist**

Whenever you're looking to schedule a meeting with multiple participants, an efficient way to weed out schedule conflicts is the Outlook Scheduling Assistant tool. In Outlook calendar, first click "New Meeting" in your toolbar. Then move over to "Scheduling Assistant" that appears at the top of the screen of the new tab. Enter your required meeting participants, and you will see at which times each attendee already has an event scheduled. The empty boxes provide the ideal meeting times for all participants.
